- 1. The meeting was called to order by President Scott Roycroft at 6:15. New members participating for the first time are John Slaby and Rick Ogden.
- 2. Minutes from the September 24, 2025, PSWC Membership meeting were approved as written. Darrel Zaccagni made a motion to accept the minutes; Sam Condo seconded the motion. The motion passed unanimously.
- 3. Treasurer's Report Brian McMahon reported we currently have \$170,000 in the bank compared to \$159,000 at this time last year. \$14,000 has already been paid for the purchase of clothing for the Clothing Store.
- 4. Announcements Scott Roycroft indicated that a Board of Directors meeting will commence immediately following the Membership meeting.

- 6. Standing Committee Reports:

- b. Membership Allen Smith reported that as of October 29th, we have1639 memberships, 97 more than last year at this time. The memberships include 3252 individuals in 42 states and the District of Columbia. Income received in membership dues is \$57,365 and \$102,327 in donations. Allen developed a graph showing the membership growth from 2006 with 412 members to the present which indicated a 330% increase.
- c. Clothing Norma Zaccagni reported the store will be open soon.

- e. Trips Helen Knerr reported that the Black Knight bus trip has been advertised and reservations need to be made by Friday, October 31st. The Trips Committee will be surveying the membership to see if there is interest in bus trips to the Michigan and/or Maryland dual meets or the Southern Scuffle in early January. There will not be a bus trip for the Drexel dual meet since group tickets are not available.
- f. Pre-Match Socials Jennifer Creighton reported there is only one Sunday home dual meet this season which is scheduled on December 7th. Jennifer is in the process of completing the necessary paperwork to hold the Pre-match Social but nothing is confirmed yet.
- g. Website Joe Niebel reported that the website is working on the Black Knight bus trip registration spreadsheet. Joe also asked that the membership at large try to group items together for the email notices sent out by the Website Committee. Special thanks went to Allen Smith for his U23 articles. Scott Roycroft asked about the performance since the switch to the upgraded server. Joe said the true test will be during the NCAA tournament due to the high volume of usage.
